**Eligibility and Media**

18 Hands Gallery invites entries for “INTERWOVEN VI”, a juried exhibition that will run from September 12, 2015 through September 27, 2015. All areas of fiber art are eligible including wearable, wall, quilts, sculptural or mixed media with fiber being the primary medium. This exhibition is open to all fiber artists working in the United States. Work must have been completed within the past 2 years. A maximum of 5 pieces per artist will be reviewed.

Wall-mounted work must not exceed 48”x48”. Each wall-mounted piece must be delivered ready to hang.

Non-wall pieces must fit on a 24”x 24” pedestal. Therefore the width or depth must not exceed 24”.

Suspended work must not exceed the length and width of a standard sized kimono and a depth not more than 4”.

Every piece must be “display-ready” and accompanied by appropriate hanging or display hardware (example: rods, display stand, manikin, etc.) Please indicate on your submissions if the display stand is included in the price.

**Prizes**

A “Best of Show” Prize (\$100) will be announced on Opening Night. Honorable Mention Awards may also be awarded at the discretion of the juror. Images of all winning pieces will be featured on 18 Hands Gallery website during the month.

**Fees**

An entry fee of \$25.00 is payable to 18 Hands Gallery for up to five (5) entries.

**Digital Images**

CDs or emailed JPEG images ([info@18handsgallery.com](mailto:info@18handsgallery.com)) will be accepted for review. JPEG format images should be at least 300 dpi. Please do not send other graphics formats.

Enter one image per work unless more than one view is necessary for detail work. There is a maximum of two images per piece. All images of accepted work will be retained until after the show. By entering “Interwoven V” and submitting digital images, the artist thereby grants permission to 18 Hands Gallery to use those images for publicity purposes. Accepted artists will be required to submit artist statements and biographies. Any work that differs appreciably from the submitted images may be rejected at the discretion of the reviewing committee.

**Insurance**

18 Hands Gallery will take great care in handling all work. The work will be insured while in 18 Hands’ possession. The artist is responsible for insuring work while in transit (both ways).

## **Sales**

All pieces accepted in the show must be for sale. The commission rate is 50%. Please quote **RETAIL** prices on any entry information. Even though price point is not a factor in the judging process, our most successful price points are up to \$475.

## **Shipping**

Accepted work may be hand delivered (appointment required) or shipped (prepaid) to arrive by September 5, 2015. Deliveries should NOT be scheduled for Mondays or Tuesdays, as the Gallery is closed those days. Insurance while in transit is the artist's responsibility. All work must be accompanied by prepaid shipping return forms or a check in the amount of the original shipping to the Gallery. Pieces not sold will be shipped back to the artist at the close of the exhibition, using the prepaid shipping method specified by the artist. 18 Hands Gallery is not responsible for returning work received without prepaid shipping.

## **Rules**

All works must remain for the duration of the show.

18 Hands Gallery reserves the right to photograph work for publicity purposes.

Submission of the entry application signifies the artist's understanding and acceptance of the rules and conditions of the show.

## **Opening**

Opening Night will be Saturday, September 12, 2015 from 6-9 PM. All artists are welcome to attend.
